Allegation #1

Interactions with the Public

Section 10(1) Conduct Undermines Public Trust

A police officer shall not conduct themselves in a manner that undermines, or is likely to undermine, public trust in policing

• It is alleged that the Respondent Officer accused the Complainant of harassing people and was told he would be arrested if he returned.

Respondent Officer (RO)

Finding: This investigation has revealed the officer was in the lawful performance of his duties and acted in accordance with all governing authorities. The Complainant was harassing individuals devastated by a critical apartment building fire. The Complainant was lawfully removed from the area and caution

Based on the available information, the Investigator has concluded that there is insufficient evidence to establish reasonable grounds that misconduct has occurred.

Therefore, the allegation is unsubstantiated.

Allegation #2

Interactions with the Public

Section 11(1) - Unnecessary or excessive use of force

A police officer shall not use force unless,

- (a) the force is used for the purpose of carrying out a duty.(b) the officer is entitled, by statute or common law, to use force for the purpose of carrying out that duty.(c) the officer is acting on reasonable grounds; and
- (d) the force used is no more than is necessary given the circumstances.
- It is alleged that the Respondent Officer used unnecessary force against the Complainant.

Respondent Officer (RO)

Finding: This investigation has revealed the officer was in the lawful performance of his duties and acted in accordance with all governing authorities. The RO used forced was minimal necessary. The RO escorted the Complainant in a controlled manner away from the scene.

Based on the available information, the Investigator has concluded that there is insufficient evidence to establish reasonable grounds that misconduct has occurred.

Therefore, the allegation is unsubstantiated.

Allegation #3 Performance of Duties

Section 19- Neglect of Duty
A police officer shall not, by act or omission, fail to perform their duties appropriately without lawful excuse if, at the time, they know or reasonably ought to know that their act or omission would amount to a failure to perform their duties appropriately.

• It is alleged that the Respondent Officer told the Complainant he was under arrest when allegedly the Complainant was assaulted by other individuals

Respondent Officer (RO)

Finding: This investigation has revealed the officer was in the lawful performance of his duties and acted in accordance with all governing authorities. The RO did not witness an assault on the Complainant nor was there an Assault captured on video. The Complainant overstepped the boundaries and invaded the privacy of others during a difficult time.

Based on the available information, the Investigator has concluded that there is insufficient evidence to establish reasonable grounds that misconduct has occurred.

Therefore, the allegation is unsubstantiated.
